#### **RHHA FIREWISE - UPDATE:**

- January 30, 2025, RHHA Firewise Meeting
  - Held our first RHHA Firewise meeting of the year. Reviewed new forms and discussed ways to improve the inspection and follow-up process.
- Proposed RHHA Fire Mitigation Policy and RHHA Annual FA Inspection Form-Lightly adjust last year's documents. Current changes were approved, added changes included changing

the order of the violations to match CalFire LE100 form. Board Members unanimously voted to adopt both documents with those changes.
